Before you join our team, WE WANT YOU TO KNOW...

During the initial pre-employment interview, an applicant shall be advised, that if he/she has been convicted of a misdemeanor crime of domestic violence, a felony or trafficking in narcotics, dangerous drugs or controlled substances, he/she shall not be considered for employment with Corrections in the following positions:

1. Probation & Parole Officer;
2. Classification & Treatment Officer;
3. Correctional Officer; and
4. A position that requires the carrying of a firearm or transportation of an inmate.

All applicants must complete an online application in the Personnel Cabinet's system, [MyPurpose](#), to apply for the vacancies in which they are interested in being considered.
