## INTRODUCTION

Supporting a successful transition to the community and maintaining stability within the offender population is central to the mission of the Kentucky Department of Corrections. The Department protects public safety by ensuring that offenders receive programming to support their successful return to the community. Programs are standardized across the Department, implemented with dedicated resources, and regularly reviewed for quality assurance.

This practical guide was prepared to highlight the Department's programs. Each program summary in this directory contains key information: a Program Description, Time Frame, Admission Criteria, Program Content, Applicable Policies and locations.

The Department maintains a catalogue of evidence-based, life skills, promising practice, and substance abuse programs to address a wide range of reentry, supervision, and incarceration needs. Program offerings vary based on available resources and the needs of the offender population. The Department of Corrections maintains a list of the programs that are currently available.

### **General Information**

#### **Definitions:**

Evidence Based Programs are programs demonstrated by scientific research to reliably produce reductions in recidivism.

Promising Practice represents a program that may have some research or data showing positive outcomes but does not meet criteria as an Evidence Based program. Promising practices have a clear focus and includes processes of accountability and evaluation.

Life Skills Programs provide strategies to assist in removing barriers for successful reintegration and address skill areas including time management, money management, use of technology, communication, and social skills.

Substance Abuse Programs is an evidence based drug treatment program for individuals with a substance use disorder.

The program was designed in a criminal justice setting for offenders involved in the criminal justice system. MRT<sup>®</sup> targets an offender’s belief system and attempts to raise their level of moral reasoning in their decision-making process. The MRT<sup>®</sup> program has been researched for over thirty years and has proven reduction in recidivism levels at multiple points of progress within the program, as well as after overall program completion. MRT<sup>®</sup> is designed to achieve formal program completion after 12 in-group steps. The workbook for this program is entitled ‘How to Escape Your Prison’<sup>®</sup> and includes the use of a separate facilitator guide.</p> <p>*MRT certification is required to facilitate this program.</p>

Program Description	<p>An <b>Evidence Based</b> ongoing Substance Use Disorder treatment opportunity for those individuals assessed with Substance Use Disorder, have completed the SAP Program, and have been classified to be housed in a jail setting. Residents in these programs are housed separately from the general population, thereby forming their own leadership within a community. Program Name	<b>Outpatient SAP - Jail</b>
Program Description	The Kentucky Department of Corrections contracts with detention centers to provide evidence based Substance Use Disorder treatment programming for individuals classified to a jail setting. Individuals assigned to the Outpatient SAP Jail program are required to work on outside detail and attend classes in the evenings.
Time Frame	The program shall be six (6) months in duration, broken into 3 phases. Early Treatment Phase (8 weeks) Middle Treatment Phase (8 weeks) Re-Entry Treatment Phase (8 weeks)
Program Credit	This program receives <b>90</b> days program credit upon completion.

SOAR is targeted towards relapse prevention, education, and reentry skills/resources.</p> <p>SOAR participants are given evidence-based curriculum from Hazelden called MORE (My Ongoing Recovery Experience)<sup>®</sup>. SOAR developed a treatment team to include Program Administrator, Unit Administrator, Clinicians, Security Staff, and Case Manager. The treatment team meets monthly to discuss offender progress and recommendations for program participation. While enrolled in SOAR, offenders are eligible to participate in up to two other programs/activities, which are regulated by the treatment team.
