INTRODUCTION

Supporting a successful transition to the community and maintaining stability within the offender population is central to the mission of the Kentucky Department of Corrections. The Department protects public safety by ensuring that offenders receive programming to support their successful return to the community. Programs are standardized across the Department, implemented with dedicated resources, and regularly reviewed for quality assurance.

This practical guide was prepared to highlight the Department's programs. Each program summary in this directory contains key information: a Program Description, Time Frame, Admission Criteria, Program Content, Applicable Policies and locations.

The Department maintains a catalogue of evidence-based, life skills, promising practice, and substance abuse programs to address a wide range of reentry, supervision, and incarceration needs. Program offerings vary based on available resources and the needs of the offender population. The Department of Corrections maintains a list of the programs that are currently available.

General Information

Definitions:

<u>Evidence Based</u> Programs are programs demonstrated by scientific research to reliably produce reductions in recidivism.

<u>Promising Practice</u> represents a program that may have some research or data showing positive outcomes but does not meet criteria as an Evidence Based program. Promising practices have a clear focus and includes processes of accountability and evaluation.

<u>Life Skills</u> Programs provide strategies to assist in removing barriers for successful reintegration and address skill areas including time management, money management, use of technology, communication, and social skills.

<u>Substance Abuse</u> Programs is an evidence based drug treatment program for individuals with a substance use disorder.

Program Description	This Evidence Based program combines group presentations and individual assignments, along with facilitator guidance when necessary. The program was designed in a criminal justice setting for offenders involved in the criminal justice system. MRT [©] targets an offender's belief system and attempts to raise their level of moral reasoning in their decision-making process. The MRT [©] program has been researched for over thirty years and has proven reduction in recidivism levels at multiple points of progress within the program, as well as after overall program completion. MRT [©] is designed to achieve formal program completion after 12 in-group steps. The workbook for this program is entitled 'How to Escape Your Prison' [©] and includes the use of a separate facilitator guide. *MRT certification is required to facilitate this program.
Time Frame	Length of time in program is dependent on individual offender progress, although offenders can generally expect to participate in 24-36 open-ended group sessions. Offenders will also be required to work individually on homework assignments as part of the program requirements.
Program Credit	This program receives 90 days program credit upon completion.
Admission Criteria	All program recommendations are based on their specific criminogenic needs identified in the KYRAS assessment.

Program Description	This Cognitive-Behavioral program is designed to assist with relapse prevention by helping offenders to recognize risky situations, cravings, and triggers. This program requires completion of eight (8) modules over a minimum of 8-10 group sessions. Groups are openended and require the completion of the 'Staying Quit'® workbook, as well as preparation of homework assignments outside of group. *MRT certification is required to facilitate this program.
Time Frame	Depending on offender needs and progression, the offender should expect to participate in a minimum of 8-10 sessions.
Program Credit	This program receives 60 days program credit upon completion.
Admission Criteria	Prerequisite: Must have successfully completed the SAP program on the current conviction and sentence they are serving on prior to admission. All program recommendations are based on their specific criminogenic needs identified in the KYRAS assessment and having a substance use history.

Program Description	The MRT [©] Mentoring program strives to ensure a higher success rate for those who have previously completed MRT [©] . A Mentor within the MRT [©] program will be held to a higher behavioral expectation than those participating in the MRT [©] group. Mentorship is beneficial for both the offender serving as the mentor, as well as for the offenders participating in the MRT [©] program. As a mentor, this offender will be expected to revisit steps 1-4 from the offender's original 'How to Escape your Prison' [©] workbook, along with completion of the 'Character Development' [©] Workbook. *MRT certification is required to facilitate this program.
Time Frame	Length of time in program is dependent on individual offender progress, although offenders can generally expect to participate in 24-36 open-ended group sessions. Offenders will also be required to work individually on homework assignments as part of the program requirements.

Program Description	This Cognitive-Behavioral program focuses on providing treatment to offenders involved in addictive/co-dependent relationships — confronting the issues of manipulation and dependence. Targets domestic violence, unhealthy relationships, enabling, substance abusers and criminality. Offenders will be required to participate in a minimum of 12 group sessions, along with preparation of homework assignments outside of group. This program utilizes the 'Untangling Relationships' workbook. *MRT certification is required to facilitate this program.
Time Frame	Depending on offender needs and progression, this program includes completion of 12 modules with a minimum of 12 group sessions utilizing the 'Untangling Relationships'© workbook.
Program Credit	This program receives 90 days program credit upon completion.

Time Frame	Completion of this program is a minimum of 21 hours of group participation, and preparation and presentation of a Reentry/Maintenance plan in front of the group. PORTAL New Direction consists of 16-modules, facilitated no more than twice per week.
Program Credit	This program receives 60 days program credit upon completion.
Admission Criteria	All program recommendations are based on their specific criminogenic needs identified in the KyRAS assessment.

Residents in these programs are housed separately from the jail general population, thereby forming their own community. This encourages responsibility and accountability through peer support and uninterrupted focus on substance use treatment.

Admission Criteria	Confirmed Substance Use Disorder Less than 24 months to parole eligibility or serve out In accordance with DOC policy, no disciplinary violations equal to Category 5 or higher within last 60 days (exception Cat 6-14 and 6-15) Category 3-11 or 4 disciplinary violation shall be reviewed by clinical staff Must complete SOTP first if required, unless subject to KRS 197.045(4). 	An Evidence Based ongoing Substance Use Disorder treatment opportunity for those individuals assessed with Substance Use Disorder, have completed the SAP Program, and have been classified to be housed in a jail setting. Residents in these programs are housed separately from the general population, thereby forming their own leadership within a community. This encourages pro-social behavior, responsibility, and accountability through peer support and uninterrupted focus on substance use treatment.
Program Description	Therapeutic Community Model which includes but not limited to: Model prosocial behaviors and attitudes; Model success or failure through trial and error learning process; Model support and guidance to peers and staff in community; Model new behaviors, attitudes, and responsible living on a daily basis; Model appropriate accountability to bring awareness to Criminal & Addictive Thinking Patterns and behaviors for self and peers; Model leadership through structure board tasks assigned to create clear and understandable expectations; "Now That You're Sober" or "The Art of Leadership" workbook
Time Frame	6 months to complete SAP Mentor Program, but may continue as SAP Mentor as an assigned job.
Program Credit	This program receives 90 days program credit upon completion. Additional credit is not awarded if transition into the assigned job of SAP Mentor.
Admission Criteria	Must have completed SAP. Individuals interested in becoming a SAP Mentor must submit an application and participate in an interview. Applicants will be selected who demonstrate strong leadership skills, ability to communicate effectively with others, continually demonstrate honesty and integrity. An applicant with any disciplinary violation shall be reviewed by clinical staff on an individual basis. While enrolled in SAP Mentor an inmate /offender may enroll in one (1) other evidence-based program. In addition anyone eligible to attend GED may do so and this will not count as the one additional program.

Program Name	Outpatient SAP - Jail
Program Description	The Kentucky Department of Corrections contracts with detention centers to provide evidence based Substance Use Disorder treatment programming for individuals classified to a jail setting. Individuals assigned to the Outpatient SAP Jail program are required to work on outside detail and attend classes in the evenings.
Time Frame	The program shall be six (6) months in duration, broken into 3 phases. Early Treatment Phase (8 weeks) Middle Treatment Phase (8 weeks) Re-Entry Treatment Phase (8 weeks)
Program Credit	This program receives 90 days program credit upon completion.
Admission Criteria	 Division of Addiction Services Branch Manager or Program Administrator will review applications. Applicant's file review indicates evidence of a substance use disorder that requires treatment. In accordance with DOC policy, no disciplinary violations equal to Category 5 or higher disciplinary within last 60 days (exception Cat 6-14 and 6-15) Clinical staff on an individual basis shall review applicants with a Category 3-11 or Category 4 disciplinary violation. Shall be within 24 months of parole eligibility date or minimum expiration date. Applicant shall have completed required sex offender treatment programming (if applicable) prior to application for substance abuse treatment, unless subject to KRS 197.045(4). Applicant shall have a custody status of Level 1 (community) or Level 2 (minimum). Applicant shall be deemed appropriate for this level of care by clinical staff within the Division of Addiction Services. Ultimate discretion for admission into the Substance Abuse Program shall remain with the Division of Addiction Services

Program Name	SAMAT - Jail Supportive Assistance with Medication for Addiction Treatment
Program Description	SAMAT is focused on preventing overdose, relapse, and recidivism for individuals with Opioid Use Disorder and/or Alcohol Use Disorder who have completed or are currently engaged in a Substance Abuse Program (SAP) through the implementation of FDA-approved medication for addiction treatment, which includes Vivitrol (naltrexone).
Time Frame	SAMAT candidates are identified and screened for eligibility approximately 2 months prior to their anticipated release from incarceration. SAMAT participants are provided medication services for up to 2 months before release from incarceration, which may include 2 Vivitrol injections prior to release.
Program Credit	This program receives 90 days program credit upon completion.
Admission Criteria	Participants must: Be identified as having an Opioid Use Disorder or Alcohol Use Disorder Complete or be an active participant in a Substance Abuse Program (SAP) Receive SAMAT education and voluntarily consent to participate. Have a verified release date within 2 months of starting participation Be recommended as appropriate for treatment by both medical and clinical staff

Program Name	PSAP—Pretrial Substance Abuse Program
Program Description	Per KRS 196.285, individuals charged with Class C or D felony having no felony convictions within the past 10 years, may be eligible for treatment as an alternative to conviction. At initial incarceration, the Jail Pre-Trial Officer may alert the Division of Addiction Services Branch Manager or Program Administrator to conduct a clinical assessment to determine eligibility for SB4/PSAP. Upon an agreement between the judge, the commonwealth attorney, the offender in question, and his/her attorney, successful completion of a jail based treatment program may serve as an alternative to a felony conviction.
Time Frame	Minimum of six (6) months but not to exceed nine (9) months.
Program Credit	Upon sentencing to DOC custody or supervision, this program receives 90 days program credit upon completion.
Admission Criteria	Confirmed Substance Use Disorder In custody in a county jail for pending charges No felony convictions (in any state) within the past 10 years Not currently on probation or parole Must not be charged with a Class A or B felony, or a Sexual Offense under KRS 17.500 Currently charged with an offense under KRS 218A or another offense and has a record of recent/relevant substance use

	SOAR offenders who are not eligible to leave incarceration upon completion of SOAR are permitted and encouraged to remain in the SOAR dorm after completion.
