INTRODUCTION

Supporting a successful transition to the community and maintaining stability within the offender population is central to the mission of the Kentucky Department of Corrections. The Department protects public safety by ensuring that offenders receive programming to support their successful return to the community. Programs are standardized across the Department, implemented with dedicated resources, and regularly reviewed for quality assurance.

This practical guide was prepared to highlight the Department's programs. Each program summary in this directory contains key information: a Program Description, Time Frame, Admission Criteria, Program Content, Applicable Policies, and Locations.

The Department maintains a catalogue of evidence-based, life skills, promising practice, and substance abuse programs to address a wide range of reentry, supervision, and incarceration needs. Program offerings vary based on available resources and the needs of the offender population. The Department of Corrections maintains a list of the programs that are currently available.

General Information

Definitions:

<u>Evidence Based</u> Programs are programs demonstrated by scientific research to reliably produce reductions in recidivism.

<u>Promising Practice</u> represents a program that may have some research or data showing positive outcomes but does not meet criteria as an Evidence Based program. Promising practices have a clear focus and includes processes of accountability and evaluation.

<u>Life Skills</u> Programs provide strategies to assist in removing barriers for successful reintegration and address skill areas including time management, money management, use of technology, communication, and social skills.

<u>Substance Abuse</u> Programs is an evidence based drug treatment program for individuals with a substance use disorder.

<u>Religious Program</u> means a program that does not have a secular purpose or a program, which has a curriculum that advances or inhibits specific religion(s) and does not qualify for program credit.

Program Name	MRT [©] - Moral Reconation Therapy MRT [©] is the product of Correctional Counseling Inc. (CCI). MRT [©] and its related products are property of CCI. CCI is the sole source provider of MRT [©] products.
Program Description	This Evidence Based program combines group presentations and individual assignments, along with facilitator guidance when necessary. The program was designed in a criminal justice setting for offenders involved in the criminal justice system. MRT [©] targets an offender's belief system and attempts to raise their level of moral reasoning in their decision-making process. The MRT [©] program has been researched for over thirty years and has proven reduction in recidivism levels at multiple points of progress within the program, as well as after overall program completion. MRT [©] is designed to achieve formal program completion after 12 in-group steps. The workbook for this program is entitled 'How to Escape Your Prison' [©] and includes the use of a separate facilitator guide.
Time Frame	Length of time in program is dependent on individual offender progress, although offenders can generally expect to participate in 24-36 open-ended group sessions. Offenders will also be required to work individually on homework assignments as part of the program requirements.
Program Credit	This program receives 90 days program credit upon completion.
Admission Criteria	All program recommendations are based on their specific criminogenic needs identified in the KYRAS assessment.

This program includes completion of 8 modules with a minimum of 8-10 group sessions utilizing the 'Coping with Anger' [©] workbook, various supplemental materials, and the completion of homework assignments prepared outside of group. *MRT certification is required to facilitate this program.
Time Frame	Depending on offender needs and progression, offenders can expect to participate in an minimum of 10-12 group sessions.
Program Credit	This program receives 90 days program credit upon completion.
Admission Criteria	All program recommendations are based on their specific criminogenic needs identified in the KYRAS assessment.

Program Description	This Cognitive-Behavioral program focuses on family values and individual priorities, and is appropriate for all parents. *MRT certification is required to facilitate this program.
Time Frame	Depending on offender needs and progression, this program includes completion of 12 modules with a minimum of 12 sessions utilizing the 'Parenting and Family Values' [©] workbook.
Program Credit	This program receives 90 days program credit upon completion.
Admission Criteria	Prerequisite: Offenders should be in an active parenting role of a minor child under the age of 18.All program recommendations are based on their specific criminogenic needs, as identified in the KYRAS assessment.

Program Name	MRT© Staying Quit MRT [©] is the product of Correctional Counseling Inc. (CCI). MRT [©] and its related products are property of CCI. CCI is the sole source provider of MRT [©] products.
Program Description	This Cognitive-Behavioral program is designed to assist with relapse prevention by helping offenders to recognize risky situations, cravings, and triggers. This program requires completion of eight (8) modules over a minimum of 8-10 group sessions. Groups are openended and require the completion of the 'Staying Quit' [©] workbook, as well as preparation of homework assignments outside of group. *MRT certification is required to facilitate this program.
Time Frame	Depending on offender needs and progression, the offender should expect to participate in a minimum of 8-10 sessions.
Program Credit	This program receives 60 days program credit upon completion.
Admission Criteria	 Prerequisite: Must have successfully completed a Substance Use Disorder Treatment program as approved by DOC on the current conviction and sentence. All program recommendations are based on their specific criminogenic needs identified in the KYRAS assessment and having a substance use history.

Program Name	MRT© Mentor MRT [©] is the product of Correctional Counseling Inc. (CCI). MRT [©] and its related products are property of CCI. CCI is the sole source provider of MRT [©] products.
Program Description	The MRT [©] Mentoring program strives to ensure a higher success rate for those who have previously completed MRT [©] . A Mentor within the MRT [©] program will be held to a higher behavioral expectation than those participating in the MRT [©] group. Mentorship is beneficial for both the offender serving as the mentor, as well as for the offenders participating in the MRT [©] program. As a mentor, participants will complete steps 13-16 from their original 'How to Escape your Prison'© workbook, along with completing of the 'Your Lifework'© Workbook. Participants must also complete a total of twelve (12) dedicated 'helping sessions' where the mentor's focus is exclusively assisting regular MRT group participants with no focus on their own step work. A maximum of 3 mentors per MRT group of 15 (ratio of 1:5) shall assist in monitoring and assisting the current involved group with step completion while working through their own specific program curriculum.
Time Frame	Length of time in program is dependent on individual offender progress, although offenders can generally expect to participate in 24-36 open-ended group sessions. Offenders will also be required to work individually on homework assignments as part of the program requirements.
Program Credit	This program receives 90 days program credit upon completion.
Admission Criteria	Prerequisites: completion of MRT [©] in the last 30 months. No convictions of major disciplinary violations or Violation of Supervision Reports for the preceding 6 months. Must still possess original 'How to Escape your Prison' workbook from MRT program completion. Must successfully demonstrate retention of MRT principles via essay questions submitted to program facilitator for review. All program recommendations are based on their specific criminogenic needs identified in the KYRAS assessment.

Program Description	This Cognitive Behavioral program was developed to confront Anti-Social and Criminal Thinking errors. Completion entails 10 modules with a minimum of 10-12 group sessions utilizing the 'Thinking for Good' [©] Workbook, and the completion of homework assignments prepared outside of group. *MRT certification is required to facilitate this program.
Time Frame	Depending on offender needs and progression, the offender should expect to participate in a minimum of 10 – 12 group sessions.
Program Credit	This program receives 60 days program credit upon completion.
Admission Criteria	All program recommendations are based on their specific criminogenic needs identified in the KYRAS assessment.

Program Description	This Cognitive-Behavioral program focuses on providing treatment to offenders involved in addictive/co-dependent relationships – confronting the issues of manipulation and dependence. Targets domestic violence, unhealthy relationships, enabling, substance abusers and criminality. Offenders will be required to participate in a minimum of 12 group sessions, along with preparation of homework assignments outside of group. This program utilizes the 'Untangling Relationships' [©] workbook. *MRT certification is required to facilitate this program.
Time Frame	Depending on offender needs and progression, this program includes completion of 12 modules with a minimum of 12 group sessions utilizing the 'Untangling Relationships' workbook.
Program Credit	This program receives 90 days program credit upon completion.
Admission Criteria	All program recommendations are based on their specific criminogenic needs identified in the KYRAS assessment.

Program Description	 This Evidence Based program combines group presentations and individual assignments, along with facilitator guidance when necessary. A recovery program for Trauma-Informed care, Breaking the Chains of Trauma is based on the MRT approach. It is designed to target trauma-related symptoms by incorporating the key issues outlined by SAMHSA's Trauma-Informed Treatment Protocol. The workbook for this program is entitled 'Breaking the Chains of Trauma'© and includes the use of a separate facilitator guide. The workbooks are designated by gender, as this program requires separate groups for women & men. *Training certification specific to the MRT Trauma (Breaking the Chains of Trauma) program is required to facilitate this program.
Time Frame	Length of time in program is dependent on individual offender progress, although offenders can generally expect to participate in 9 -12 open-ended group sessions. Offenders will also be required to work individually on homework assignments as part of the program requirements.
Program Credit	This program receives 60 days program credit upon completion.
Admission Criteria	All program recommendations are based on their specific criminogenic needs identified in the KYRAS assessment.

Time Frame	Depending on offender needs and progression, offenders can expect to participate in a minimum of 9-12 group sessions.
Program Credit	This program receives 45 days program credit upon completion.
Admission Criteria	All program recommendations are based on their specific criminogenic needs identified in the KYRAS assessment.

Program Name	PORTAL New Direction
Program Description	This Life Skills program is designed to provide information and resources to address the most common reentry needs and barriers. Some barriers addressed in this program are housing, employment, transportation, money management, parenting, etc. *PORTAL New Direction certification is required to facilitate this program.
Time Frame	Completion of this program is a minimum of 21 hours of group participation, and preparation and presentation of a Reentry/Maintenance plan in front of the group. PORTAL New Direction consists of 16-modules, facilitated no more than twice per week.
Program Credit	This program receives 60 days program credit upon completion.
Admission Criteria	All program recommendations are based on their specific criminogenic needs identified in the KYRAS assessment.

Program Name	Substance Abuse Program – Jail
Program Description	 An Evidence Based Substance Use Disorder treatment opportunity for those individuals assessed with Substance Use Disorder and classified to be housed in a jail setting. Residents in these programs are housed separately from the jail general population, thereby forming their own community. This encourages responsibility and accountability through peer support and uninterrupted focus on substance use treatment. Therapeutic Community Model which includes but not limited to: Practicing prosocial behaviors and attitudes; Experiencing success or failure through trial and error learning process; Being supported and guided by the community and staff; Internalizing new behaviors and attitudes and becoming accustomed to living them on a daily basis; Accountability is utilized by staff and offenders to bring awareness to Criminal & Addictive Thinking Patterns and behaviors; Organization through a structure board that creates clear and understandable expectations; Curriculum- Hazelden "New Direction"[©] Workbook Series (Intro to Treatment, Criminal & Addictive Thinking, Drug & Alcohol Drug Education, Socialization, Co-Occurring Disorders, Relapse Prevention, and Preparing For Release.)
Time Frame	Time frame for completion is an average of 6 months.
Program Credit	This program receives 90 days program credit upon completion.
Admission Criteria	Confirmed Substance Use Disorder Less than 24 months to parole eligibility or serve out In accordance with DOC policy, no disciplinary violations equal to Category 5 or higher within last 60 days (exception Cat 6-14 and 6-15) Category 3-11 or 4 disciplinary violation shall be reviewed by clinical staff While enrolled in SAP an inmate /offender may enroll in one (1) other evidence-based program. In addition anyone eligible to attend GED may do so and this will not count as the one additional program.

Program Name	Substance Abuse Program Mentor – Jail
	An Evidence Based ongoing Substance Use Disorder treatment opportunity for those individuals assessed with Substance Use Disorder, have completed the SAP Program, and have been classified to be housed in a jail setting. Residents in these programs are housed separately from the general population, thereby forming their own leadership within a community. This encourages pro-social behavior, responsibility, and accountability through peer support and uninterrupted focus on substance use treatment.
Program Description	 Therapeutic Community Model which includes but not limited to: Model prosocial behaviors and attitudes; Model success or failure through trial and error learning process; Model support and guidance to peers and staff in community; Model new behaviors, attitudes, and responsible living on a daily basis; Model appropriate accountability to bring awareness to Criminal & Addictive Thinking Patterns and behaviors for self and peers; Model leadership through structure board tasks assigned to create clear and understandable expectations; "Now That You're Sober" or "The Art of Leadership" workbook
Time Frame	Time frame for completion is an average of 6 months for SAP Mentor Program, but may continue as SAP Mentor as an assigned job.
Program Credit	This program receives 90 days program credit upon completion. Additional credit is not awarded if transition into the assigned job of SAP Mentor.
Admission Criteria	Must have completed SAP. Individuals interested in becoming a SAP Mentor must submit an application and participate in an interview. Applicants will be selected who demonstrate strong leadership skills, ability to communicate effectively with others, continually demonstrate honesty and integrity. An applicant with any disciplinary violation shall be reviewed by clinical staff on an individual basis. While enrolled in SAP Mentor an inmate /offender may enroll in one (1) other evidence- based program. In addition anyone eligible to attend GED may do so and this will not count as the one additional program.

	Supporting Others in Active Recovery (SOAR) supports participants in their goal to stay in a safe and recovery supportive environment after completing their program. SOAR is targeted towards relapse prevention, education, and reentry skills/resources.
	SOAR participants are given evidence-based curriculum from Hazelden called MORE (My Ongoing Recovery Experience.) While enrolled in SOAR an inmate/participant may enroll in one (1) other evidence-based program. In addition, anyone eligible to attend GED may do so and this will not count as the one additional program. SOAR inmate/participant may attend Portal New Directions and any variation of MRT at the assigned institution.
Program Description	SOAR participants who are not eligible to leave incarceration after completion of SOAR, are permitted and encouraged to remain in the SOAR dorm after completion. SOAR graduates are given the same opportunities for continuum of care as active participants. SOAR graduates who choose to remain on the dorm are required to demonstrate leadership skills by leading educational groups, AA/NA, tutoring and mentoring active participants in SAP and SOAR.
	SOAR is also designed to encourage family communication and engagement. SOAR clients are given the opportunity to participate in Family Engagement events. During these events, family and participants are given an opportunity to learn the importance of family involvement and recovery.
