# <u>DEPARTMENT OF CORRCTIONS</u> <u>Addiction Services of Kentucky</u>

The Division of Addiction Services is responsible for the clinical and administrative oversight of all Substance Use Disorder (SUD) treatment related to inmates, parolees, and probationers within our care as determined by statute. This oversight includes treatment in prisons, jails, Reentry Service Centers (RSCs), Recovery Kentucky Centers (RKCs), and Intensive Outpatient Programs (IOPs) through a partnership with regional Community Mental Health Centers (CMHCs). Substance Use Disorder clinical determination for probations and parolees through a network of Social Services Clinicians in the Probation & Parole districts are also included in the oversight.

Community based Social Services Clinicians are encouraged to utilize all evidence-based resources within their respective regions. This may include agencies not formally contracted with the Department. You can always **dial \*988** for assistance anywhere in the state.
