**RCC** RESTRICTED CUSTODY CENTER IS A BUILDING DESIGNED FOR RESTRICTED CUSTODY HOUSING WHICH IS SEPARATE FROM THE JAIL

**JRC** JAIL RESTRICTED CUSTODY BEDS ARE IN A SECTION OF THE JAIL DESIGNED FOR RESTRICTED CUSTODY HOUSING

**Class D Inmates** - Inmates serving a sentence for conviction of a Class D felony. The total sentence must be five (5) years or less, with the exception of a sex

**Community Custody** - Class C inmates who have been classified at the lowest custody level with 18 months or less to their minimum expiration date or parole

**Alternative Sentence** - A convicted felon serving his/her sentence in a local jail under special conditions that the court may impose such as work release,
