JRC Jail Restricted Custody beds are in a section of the jail designed for community/minimum custody housing.

Class D Inmates Inmates serving on only Class D felonies with a five (5) year sentence or less. If serving on a sex offense, the sentence must be two (2) years or less. Inmates designated as D Extended (DE) are reported as Class D.

CC Eligible Inmates Inmates serving on Class C felonies, Class D felonies which total more than five (5) years, or a combination of the two, who are within twenty-four (24) months of their minimum expiration date or their parole eligibility date and have been classified as community custody (Level 1).
