

## Annual Awards Luncheon Honors DOC's Best

The 2012 Department of Corrections' Annual Awards Luncheon was held at the Griffin Gate Marriott in Lexington.

This year's ceremony was held in conjunction with the joint SSCA / KCCD conference. There were approximately 500 attendees from across the state who turned out for the largest DOC event of the year.

Gary Beckstrom, a 33-year veteran of the Department of Corrections, was named "Warden of the Year."

Beckstrom, warden at Eastern Kentucky Correctional Complex, was recognized for his outstanding commitment to the department, and to the community, immediately after and in the weeks that followed the March 2 tornado that destroyed West Liberty.

Christie Feldman was named "Probation & Parole Supervisor of the Year." Feldman has served as supervisor of District 7 for the past 10 years. Among the reasons Feldman was selected were her district's community involvement and

## Sister Dorothy Schuette Honored by DOC

This year the department honored Sister Dorothy Schuette, O.S.B., with the 2012 Lucille Hurt Robuck "Commitment to Corrections" Award.

"Sister Dorothy" as she is affectionately known," serves the Northern Kentucky community in a variety of ways. She is a tireless advocate and her years of service are evidence of her commitment to assist offenders, and their families, as they transition from prison or jail to their community.

Sister Dorothy serves as the Pastoral Associate at Our Mother of God Catholic Church in Covington. She also coordinates jail ministry in seven Northern Kentucky counties. This role includes coordinating volunteers that visit offenders in local jails to discuss their challenges, communicate resources, or just talk about their feelings. This may be the only opportunity for the offender to talk with someone that just listens without passing judgment.

Sister Dorothy also has a role in the Second Chance Act Mentoring Grant awarded to Catholic Charities in Covington. The grant provides offenders returning to the Northern Kentucky area an opportunity to secure a oneon-one mentor to ease their transition to the community.

She has been a very active member of the Northern Kentucky Reentry Team. Her service has propelled the team from planning for increased capacity and services in the area, to providing a comprehensive reentry program for female offenders struggling with mental health and substance abuse issues.


Task Force to address the transition needs of offenders returning to their communities.

Most notably, when Sister Dorothy sees a need for something she makes it happen. Offender families needed a community-based support system and Sister Dorothy developed a monthly family support group for families to gather and discuss their feelings and expectations about the criminal justice process. The support group provides a unique opportunity for families and friends to openly communicate the impact of incarceration on their lives.






