CC Eligible Inmates Inmates serving on Class C felonies, Class D felonies which total more than five (5) years, or a combination of the two, who are within twenty-four (24) months of their minimum expiration date or their parole eligibility date and have been classified as community custody (Level 1).

Alternative Sentence Inmates who have been convicted of, plead guilty to, or enters an Alford plea to a felony offense and is sentenced to jail as a condition of conditional discharge or as a condition of probation.

Facility Security Indicates secure (S), non secure (N), secure programming only (SP) or non secure programming only (NP) and is used for sorting purposes.

Inmate Custody Indicates secure male (SM), secure female (SF), non secure male (NM), non secure female (NF) or not applicable (N/A).
